

# Annex No. 1

## to the Directive on the final thesis, their bibliographic registration, originality verification, storage and accessibility

The Directive on the final thesis, their bibliographic registration, originality verification, storage and accessibility, which entered into force on January 21, 2019, is amended as follows:

1. Appendix No. 3 to the Directive, the text of which is attached to this Annex, is amended.
2. The following shall be added after the text of Appendix No. 6 to the Directive:

### “CITATION EXAMPLES DESCRIBING THE USE OF ARTIFICIAL INTELLIGENCE TOOLS

The use of artificial intelligence tools (e.g., generated texts, images, translations, etc.) needs to be cited. When citing, one should proceed in a similar way as when working with other sources, distinguishing between citations and paraphrases.

Directly in the text of the thesis, the citation text shall be entered, followed by the **AI text in brackets**, created by the author and the **year of generation**. (**AI Learner Typology 2024**).

References are included in the *List of Bibliographic References* (see above) with the following information:

*AI TEXT TITLE* created by the author, year of generation. [online]. In: name of the AI service used. Version. Available from: URL of the service or of the generated material. [date of generation]. Prompt: applying learner typology by intelligence type in foreign language teaching

Example of an entry in the List of Bibliographic References:

*AI LEARNER TYPOLOGY*, 2024. [online]. In: ChatGPT. Version 3.5. Available from: <https://chat.openai.com>. [10.3.2024]. Prompt: assignment

If using automatic translators (e.g., DeepL, GoogleTranslate, Smartcat, Linguee, etc.), the source must be cited and *translated by [name of the tool used]* should follow the citation.”

3. This Annex shall enter into force and effect on March 26, 2024.
